

Healing from Loss

1. Take good care of yourself

Make sure that you eat well and get enough rest. It sounds simple, yet many people fail to do it. Grieving can be a draining experience – mentally and emotionally. It is important to maintain your strength.

2. Educate your friends and family

Often, people don't know what to say to those who are grieving, so they make comments like "Be strong" or, "You have to keep busy". At best these cliches are not helpful. At worst, they are downright harmful and annoying.

Such comments are made partly because so many of us are uncomfortable with our own grief. But, however well intended, they tend to downplay the griever's true feelings. Grievers don't want intellectual information or advice. Ask them what happened, to tell you their story, and then put both hands over your mouth. Let the griever talk. Because they want to tell about the loss they have had, and stories about that person. I believe honest communication is the key. One of the best things you can say to a grieving person is, "I can't imagine what this is like for you." Or, as the griever, you say, "You know, right now I'm doing OK, but this morning was really not so good."

3. Allow yourself time

Grieving always takes longer than expected. It is important to remember that there is no set

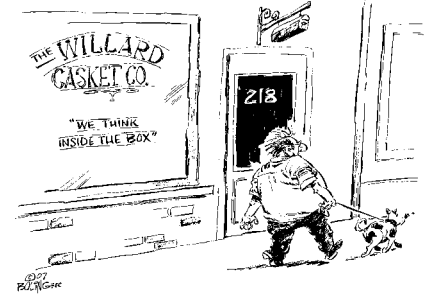
time frame on grieving. Some people expect it to be over after a few months but in fact a lot of people experience numbness for that first while. Some find that their grief is heightened on all the significant dates and occasions through the first year of mourning.

Most grief counsellors agree that genuine healing begins long after the first few months. Our culture is quick to tell people to move on. Right after a loss, people are generally pretty good about helping, but that often ends after a month or so. It is when people begin to experience the loss at a deeper level, sometimes a number of months after the loss has occurred, when they really need help.

4. Look for meaning

Sometimes the loss of someone close to us can act as a wake-up call, providing the impetus for change in ourselves. We may re-prioritize our values, our relationships and even our work. The loss of somebody important certainly makes you reconsider the relationships you have left, many realize that life is short. But at the end of life few people wish they had spent more time at the office. Most would rather have spent more time with the people that matter and on things that really made a difference.

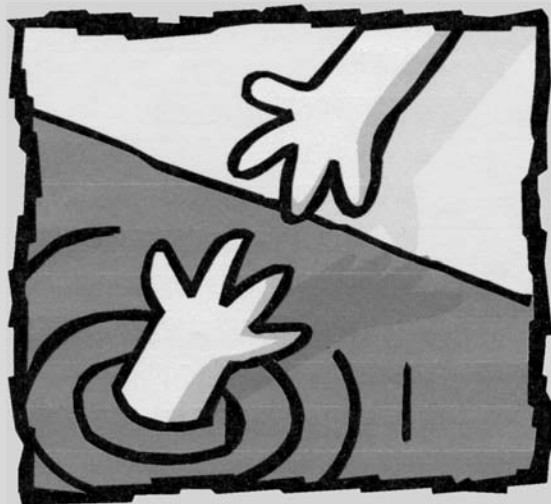

A Film to Watch

A Family Undertaking is a provocative documentary which explores the complex psychological, cultural, legal and financial issues surrounding an important and growing trend, the home funeral movement. It profiles families who have made the decision to forego the typical mortuary funeral and instead prepare their loved-one at home for burial or cremation. They are learning and experimenting with ways to make the death of a beloved family member or friend more personal and meaningful. In several cases, the dying persons themselves are participating in planning their own funerals.

Death Away from Home

If death occurs in the USA the contact number 802-482-3437 will give your survivor(s) the number of the nearest cooperating memorial society funeral home. This funeral provider will in turn try to contact the funeral home in Canada (likely through the home society) where your pre-arrangement is on file, to determine what your wishes are and then carry them out as best circumstance will permit.

The "In Canada" number is that of your MSNO at toll free 1-800-203-1539. MSNO will contact the funeral provider with whom you are registered and advise them of the death. In the event that pre-arrangement filing is still pending, your survivor(s) will be advised of the names of local cooperating funeral providers, and they will have to decide whom they wish to use.

Have You Ever Wondered?

What is the system in Ontario for retrieval of tissue (skin, bones and heart valves) after death?

The Trillium Gift of Life network (TGLN) has advised the Federation of Ontario Memorial Societies (FOOMS) as follows:

There are 6 tissue banks in Ontario and retrieval of tissue takes place almost exclusively in hospitals. There is no payment made or received for these retrievals and consent is obtained from the family by the healthcare professional or the TGLN coordinator.

These tissue banks at present can supply only about 8% of the need for these transplants in Ontario, so 92% comes from purchases made from other provinces or the U.S.A. (It should be noted that there is sometimes a profit motive in the purchase of tissue/bone in the U.S.A.). Hospitals can order direct from these outside sources and there are no controls on these purchases, although it is assumed great care is taken to ensure the purchases are made through reputable biomedical organizations.

Planning your own Funeral

Did you know that under Ontario law a family may carry out all the funeral arrangements for a family member without using the services of a funeral home? The body is removed from the place of death by the family (if death does not occur at home), prepared and placed in a home-made or purchased casket. If desired, a home visitation or wake may take place before the family transport the body for cremation and/or burial. Various documents must be obtained: certificate of death, provided by the doctor; coroner's certificate if cremation is chosen; burial or cremation permit acquired from the municipality.

MSNO Privacy Policies

The Federal Privacy Act (PIPEDA – January 1, 2004) has raised everyone's awareness of the need to protect the privacy of the individual. In order that the privacy of our members is protected as required by the Act, the Board guarantees that the membership information stored in our membership database is held in confidence. In addition the board guarantees:

1. The membership database contains only such information as is necessary to identify individuals as members of the Society and record the information they assign to us.
2. Membership information is available only on request of the member or the member's designate.
3. At the request of a member, that member's name and other recorded information are removed from the database.
4. Upon proof of death, a member's name and other information are removed from the database.
5. We do not sell or exchange membership lists with any other organization.
6. We do not exchange promotional or other material with other organizations for inclusion in the Member's Planning Kit.
7. Records of telephone calls (Telephone Logs) are maintained by the Telephone Coordinator for one year to allow for follow-up by the caller or the telephone volunteer. After that period, they are destroyed.
8. All board members and volunteers must sign Statement of Confidentiality and Code of Ethics.
